- 4. Usage** - Digital Only Photography reserves the right to use the photos for demonstration, display, publication or other purposes.
- 5. Postponement/Cancellation** - In the event of a postponement or cancellation of the contract, any extra deposits will be returned, however the Reservation Fee is non-refundable. No refunds will be made after delivery of the product(s).
- 6. Liability** - Digital Only Photography takes the utmost care with respect to the production, postproduction and delivery of the product(s). However, in the event Digital Only Photography fails to comply with the terms of this contract, Digital Only Photography liability is limited to the Reservation Fee and deposits paid by the client.

- 8. Additional Charges** - After the product(s) has been delivered to the Client, there will be a charge for re-editing at the rate of \$100.00 per edit hour; there will be no charge for re-editing less than one edit hour. Re-editing is available to the client for a period of (7) seven days after delivery of the product(s). Unforeseen parking fees and tolls incurred will be charged to the client.
